



## NOTICE OF INVITATION



### **FOR PROCUREMENT OF MEDICINE CONSUMABLE ITEMS, IMPLANTS AND LENSES FOR DIFFERENT SPECIALITIES AND LAB INVESTIGATION OF SHEIKH KHAILFA BIN ZAYYED AL NAYAN MEDICAL COMPLEX, MASTUNG ROAD QUETTA.**

Sealed bids are invited from registered firms, pharmacies, and suppliers dealing in business of Medicines, Consumable items, implants, lenses and laboratory investigations.

The procurement process shall be conducted in accordance with and **BHCP Policy Guidelines 2024**, issued by the Health Department, Government of Balochistan.

#### **METHOD OF PROCUREMENT**

- I. A single-stage, Two -envelope procedure least cost (package wise) selection method through quotation.
- II. The data sheet of items has been classified in different categories of Medicines , Consumable items, Implants, lenses and lab investigations. Bidder are advice to quote items as per given categories.
- III. The quoted items must fulfill the defined specification as laid down in data sheet; nonfulfillment will lead disqualification of specific items.
- IV. The shelf life must be 75% from the date of supply of medicines, consumables and others enlisted local and imported items.
- V. After completion of evaluation comparative statement will be issued and work orders will be placed to the successful bidders after signing of contract agreement by procurement committee of SKBZAN as per BHCP policy guidelines.
- VI. The list of required medicines, consumables items implants and laboratory investigations details can be obtained from the office of the undersigned during official timings.

**MODE OF PAYMENT:** Payments will be made within **120 days** after completion, of supply subject to fulfillment of all required official/financial documentation.

- I. All payments will be made via bank transfer to the firm's official account.
- II. The procuring agency has the authority to cancel the procurement process at any stage or extend the date of quotation submission.

**SUBMISSION DEADLINE:** Sealed Quotations must be submitted by **Monday 27th, July 2026**, no later than **11:00 AM**, at the office of the undersigned.

**QUOTATION OPENING:** All submitted quotations will be opened in presences of bidders on **Monday 27th, July 2026, 12.30 pm** by Procurement Committee at the office of SKBZAN, Quetta.

**SPECIAL CONDITION:** The quoted items in the category of medicine (**oral dosage form**) must fall in top 140 manufacturers as per IMS ranking IQVIA list last quarter for Pakistan.

**ELIGIBILITY CRITERIA:** The firms must fulfill the defined eligibility criteria non fulfillment of any factor will lead to disqualification.

- I. The firm must be registered with the Income Tax and listed as an Active Taxpayer with the Federal Board of Revenue (FBR). Attached NTN Certificate and ATL Certificate.
- II. The firm/company must hold a valid sales tax registration with the FBR.
- III. Drug Sale License of Pharmacy/firm issued by licensing authority Health Department Government of Balochistan.
- IV. Financial Capacity, / the bidder must submit bank account annual turnover of Rs. 10 million. Attach original bank Certificate.
- V. DRAP registration, all quoted items must be registered by DRAP.
- VI. The bidder Must have Pharmacy/office in Quetta City, Attach latest Paid Utility Bills along-with Tenancy Agreement or Ownership Agreement.
- VII. The financial quotation must be less then trade price (TP) and in accordance with institutional rates.
- VIII. Declaration on Affidavit duly signed by Notary Public/Oath Commissioner on **Rs.100/-** Stamp Paper declaring past performance of the Bidder, Price reasonability, Delivery time, Non-Black listing, Agreement with all the terms & conditions.
