Procurements: Procurements shall be made under the Balochistan Public Procurement Rules, 2014. **Eligibility of Bidders:** The bidder must fulfill the following eligibility requirements: i. Must have completed at least two (02) assignments of similar nature and complexity, each worth PKR 4 million, during the previous three (03) years. ii. Must have an accumulated turnover of at least PKR 8 million during the three (03) subsequent previous years. iii. Must be registered as an Active Taxpayer. iv. Must possess a valid BRA Registration Certificate. v. Any procuring agency of Pakistan must not currently blacklist the bidding firm. vi. The bidder must demonstrate capacity to conduct digital field data collection using CAPI-based systems such as ODK, KoBo or equivalent, including GPS/time stamping, electronic forms, data transmission, data quality checks and secure management of field data. vii. The bidder shall provide bid security in the amount, form and validity prescribed in the bidding documents. viii. The bidder shall submit a signed Declaration of Independence and No Conflict of Interest confirming that the firm, its affiliates and proposed key personnel are not involved in the implementation of the Deworming Initiative.
